On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

The Board offered condolences to the O.T. Bishop family, long time Hamilton Township Trustee and Hamilton Township business owner, upon his passing.

## PUBLIC HEARING

CONTINUATION OF THE PUBLIC HEARING TO CONSIDER AMENDMENTS TO ARTICLE 1, 2, 3 AND 4 OF THE WARREN COUNTY RURAL ZONING CODE

The Board reconvened the public hearing to consider amendments to the Warren County Rural Zoning Code to further consider the proposed amendments to Article 3.103.2(C) (Panhandle Lots) and Article 2.205 (Composting Facility).

Mr. Yetter reviewed the events from the last public hearing and presented requested changes relative to a diagram and amended wording for Panhandle Lots.

There was discussion relative to the minimum road frontage for a panhandle vs. a regular lot.

It was determined that the road frontage minimum will vary by zoning classification.

There was then discussion on whether this change will make it easier on developers to develop property with panhandle lots.

Upon discussion, the Board stated their concurrence with the proposed changes.

Mr. Yetter then presented proposed amendments to the Zoning Code that the Board had requested relative to the requirement of a site plan review application in the event that the Board of Zoning Appeals (BZA) issues a Conditional Use Permit.

Commissioner Young questioned Mr. McGary on his recommendation regarding the proposed changes.

Mr. McGary explained the Board of Zoning Appeals process and the fact that, if the BZA issues the conditional use permit, the Commissioners cannot deny the use, only limit the conditions relative to the use.

Commissioner Young then questioned the ability to remove the conditional use from the I2 zoning classification and limit it to SD and ST zone.

Mr. McGary stated his initial opinion that the Board has that ability.

Commissioner Grossmann reviewed that the last discussion on the topic was to be more restrictive than current by requiring a conditional use along with a site plan review. He then clarified that the discussion now is to be even more restrictive.

The Board concurred that their desire is to be as restrictive as possible with the siting of a composting facility while still meeting the constitutional requirements.

Mr. McGary requested the Board continue the discussion relative to composting facility text amendments in order for him to research case law relative to the matter.

Upon further discussion, the Board resolved (Resolution #15-0172) to approve a modification of a portion of the text amendments to the Warren County Rural Zoning Code to amend portions of Article 1, Article 2, Article 3 and Article 4 and continue the public hearing to March 3, 2015, at 10:00 a.m.

Martin Russell, Economic Development Director, was present to discuss the concept of utilizing the portion of the racino money allocated to Warren County from the legislature in order to incentivize private lending.

Mr. Russell explained the possibility of utilizing the funds to leverage private sector financing for developments and/or job creation. He stated that the concept would be similar to a revolving loan fund.

On motion, upon unanimous call of the roll, the Board entered into executive session at 10:30 a.m. to discuss economic development assistance pursuant to Ohio Revised Code Section 121.22 (G)(8) and acquisition of property pursuant to Ohio Revised Code Section 121.22 (G)(2) and exited at 12: 02 p.m.
