DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Martin Russell, Deputy County Administrator, was present for a work session to discuss the lease agreement with American Tower for the cellular tower located at the Warren County Fairgrounds.

Mr. Russell reviewed the history of the current lease and presented three (3) options for the Board's consideration as follows:

Option #1 - Allow Current Lease to Continue w/no changes

Lease is through 2029

15% escalation with each new term

Tenant maintains option regarding renewal(s)

Current revenue = \$2,623 monthly with an additional \$3,101 in revenue sharing = \$5724 (For comparison, this is \$4,167 more per month that what is received for the tower located at the sewer plant on 22/3)

Option #2 - Lease Extension (6 additional terms x 5 years)

Lease would be extended until 2059

\$25,000 upfront payment

15% escalation with each new term

50% revenue share of any new sublease(s)

Tenant maintains option regarding renewal(s)

Any requested/required movement of the tower would need to be approved by the tenant and paid for by the County

Option #3 - Lease Extension (6 additional terms x 5 years) - change in option "control"

Lease would be extended until 2059

\$12,500 upfront payment

15% escalation with each new term

50% revenue share of any new sublease(s)

Tenant maintains option regarding renewal(s) – first two terms (2039)

Any requested/required movement of the tower would need to be approved by the tenant and paid for by the County

Tenant and Landowner have option renewal rights – terms 3 through 6 (2040 – 2059)

Language to be drafted by attorneys for adequate relocation and/or ending of contracts between American Towers, LLC and subleases

There was discussion relative to the three options.

Bruce McGary, Assistant Prosecutor, stated that the motivation of the cell tower companies to extend the lese is due to the cost to remove the structure at the end.

Upon further discussion, the Board stated they desire Option 1.

Dustin Ratliff, Emergency Preparedness Coordinator for the Warren County Combined Health District, was present to discuss updates on COVID 19.

Mr. Ratliff discussed the staffing need in hospitals. He discussed the specialized training needed to work in a Pulmonary ICU, meaning you cannot relocate an emergency room nurse to work in the ICU without additional training.

There was discussion relative to the medical treatments being administered as well as the specialized beds that are being used.

Commissioner Young reviewed today's Ohio Dashboard relative to today's statistics.

There was discussion relative to the vaccine relative to emergency use authorization timing and the timeline of distribution as well as the priority of who will receive the vaccine first.

Mr. Ratliff stated that is estimated that on December 22, 2020, hospitals and local health departments are scheduled to receive a shipment of vaccines. He stated that the most vaccines that Warren County could receive is 2000 doses, but they have no idea how many they will actually receive. He then stated that they are planning for any possible option in order to get the vaccine to the people as soon as possible.

Commissioner Young encouraged the public to remain diligent and stated this is no time to let down your guard.

There was discussion relative to the current study showing that you can have transfer by air, not only by droplet, in an indoor, enclosed environment.

Mr. Ratliff iterated the following:

- 1. If you are sick, stay home
- 2. Maintain a social distance
- 3. Limit social interaction with mask wearing

Lelle Hedding, Deerfield Township Trustee, discuss the Governor's announcement relative to Antigen Positive tests. She questioned Mr. Ratliff on how the state determines positive cases if it is not a positive test.

Mr. Ratliff discussed the process in which cases and determined probable vs. positive.

Upon further discussion, the Board thanked Mr. Ratliff for his dedication and hard work on behalf of Warren County.

Upon motion the meeting was adjourned.
